## Edisto Kennels, LLC and Owner Agreement

I understand that this is a legally binding agreement between the Owner hereinafter referred to as "Owner" and Edisto Kennels, LLC hereinafter referred to as "EK".

I understand and agree that I am solely responsible for any harm caused by my pet or to my pet while my pet is attending EK.

I understand and agree that admitting my dog to daycare, EK has relied upon my representation that my dog is in good health, does not have and has not had within the last 30- days any communicable diseases and has not harmed or shown any aggressive behavior towards any person or another dog.

I understand that EK and their staff will not be liable for any problems that develop, provided that reasonable care and precautions are followed and I hereby release them of any liability of any kind whatsoever arising from my pet's attendance and participation at EK.

Owner agrees to provide EK with emergency contact information as to who is authorized as the responsible person to oversee any major problems that should arise. If unable to reach contact person for any reason in a timely manner, Owner authorizes EK to resolve emergencies at sole discretion.

I understand that if my pet develops any problems, becomes ill or requires professional attention, EK will resolve my pet's emergency at its sole discretion and Owner will cover the cost as needed.

I understand all pets must be current on all vaccinations including Rabies, Distemper, Combo and Bordetella and adhere to regular flea, tick and heartworm treatment. Proof of vaccinations will be required every year. Please email records to [edistokennels@gmail.com](mailto:edistokennels@gmail.com) or text to 843.631.0144 before bringing dog to kennel.

In the event of injury to the dog, Owner hereby authorizes EK staff to seek immediate medical care for the dog with EK staff choosing the veterinarian and with Owner responsible for any and all veterinarian expenses.

In the event respiratory infection/"Kennel Cough" symptoms are present to the dog, Owner agrees to pick up the dog within 24 hours of symptoms being present. The dog will be quarantined away from all other dogs until Owner picks up the dog. If

Owner is not present to pick up the dog, Owner authorizes EK staff to contact the emergency contact person listed below to pick up the dog. Owner understands that Bordetella vaccinated dogs are still at risk of developing "Kennel Cough" and/or other respiratory infections.
